Please be advised all Swimmers under (16) are required to complete a swim test prior to entering water over 3 feet/dive well. Non qualified swimmers/ small children must be in the water with an adult at all times. Children found unattended in pool or other areas will be removed and swimming privileges will be revoked for the day. Non swimming adults are forbidden to allow children access and use of diving boards without an adult being in the water up by the boards. Non adherence will lead to revoked pool privilege for the day. Children under 15 years of age must have adult supervision at all times and are not allowed to use facilities without an adult accompanying them. Drop offs are not permitted.

Section 1. Membership Classifications and Fees

**Seniors are age 60 and up.*

All membership rates are based on paying in full. Additional processing fees for monthly installments will be applied where/when applicable.

All memberships are annual

Family Membership \$600.00

Senior Family Membership \$540.00

Family memberships are for up to six (6) immediate family members **residing in same household**. For adults over 21, please provide proof of residency.

Additional immediate family members may be added to either plan for an extra \$50 per year, per person.

Senior Couples Membership \$420.00

Couples Membership \$480.00

Valid for two (2) individuals residing together same household please provide proof of residency.

Senior single Membership \$300.00

Single Membership \$360.00

College Student Membership \$180.00 (only ages 18-21) *Must present current college ID*

Section 2. Dues/Payment Options

There are two options for paying membership dues:

1. **Pay in full.** Must be received and postmarked no later than 14 days of signing up. Entry will not be granted until full payment is received.
2. **Automatic Bank Draft.** You may choose to have funds automatically withdrawn monthly for one year.

Section 3. Late Fees/Insufficient Funds

A \$36.00 late fee will be added to any payment seven days past due.

Payments returned for insufficient funds will be charged a \$36.00 bank fee for every process attempt made.

*** Bank attempts two separate times for initial payment.**

If member has more than two (2) incidences of insufficient funds or returned checks, auto draft payments will stop immediately, requiring all out standing payments be made in cash or money order, with remaining balance due and paid in full.

Section 4. Membership Cards/Access to Amenities/Lost Cards

At the beginning of season, members will receive membership card/s by mail or in person. Cards must be presented at time of entry to any facilities or events taking place on property and must be presented each visit.

Section 5. Pool

Hours: The pool opens from 12:00 PM to 7:00 PM daily, with a lifeguard typically present from 12:00 PM– 7:00 PM. All members are welcome to use the pool. Children (under 16) Must be accompanied by an adult at all times while utilizing the pool.

Rules:

The rules will be included within this membership agreement. A copy of the rules can also be found at www.clubwoodbridge.com/rules. Members and guests are expected to abide by all pool rules and regulations.

Members/Guests in violationof these rules and regulations or with repeated offenses will be at risk of suspension and/or termination.

Section 6. Tennis Courts

All members and guests are welcome to enjoy the tennis courts please reserve your court time in advance. Members and guests must abide by all tennis court rules and regulations. Any one in violation of these rules and regulations may be at risk for suspension and/or termination.

Section 7. Club House

Adult members and adult guests are welcome to enjoy the clubhouse and amenities on a first come, first-serve basis. Children (under 16) must be accompanied by an adult at all times while utilizing equipment, or entry to clubhouse.

The clubhouse is generally accessible when the pool is open unless it is being privately rented. The kitchen is reserved for private events and employees only. No wet bathing suits in the clubhouse. Please keep the doors closed during the summer (as we try to keep the inside cooler).

Section 8. Guests/fees

Members must be up-to-date on all dues and fees and be in good standing with Club Woodbridge to have guests.

Members are welcome to bring guests for an additional \$7.00 a day.

Same individual may only visit as a guest three (3) times during season After their third visit individual will be refused entry.

Only Exception is out of town visiting guests more than 45 miles or more. ID of visitor(s) may be presented at time of entry.

Section 9. Special Events at Club Woodbridge

The clubhouse, pool, and grounds are available for rent by members and non-members. Members enjoy the perks of a 20% discount on facility rental.

A rental fee shall be established at the time of each individual rental.

A 50% deposit and damage security deposit is required at time of signing with remaining balance paid in full 1 week prior to event.

Section 10. Events Hosted By Club Woodbridge

Club Woodbridge may host events, some are free to members and others may require additional fees. Members must be in good standing to participate

Funds for scheduled events which are cancelled "due to unforeseen circumstances", will be reimbursed 60% of any pre paid fees with 40% retained by Club Woodbridge for incurred expenses. If incumbent weather cancels an activity or scheduled event, the activity or event will be rescheduled for a later date and no refund will be given.

Section 11: Termination or Suspension of Membership

Suspended and/or terminated members shall lose all rights to participate in club activities or use of facilities at the date of suspension and/or termination and may not reapply for membership. Illegal Drug use of any kind is prohibited and results in removal and termination.

Persistent late payments or returned payments will lead to suspension and could be grounds for termination.

Club Woodbridge has the right to terminate without notice any individuals membership or refuse entry as deemed necessary.

LACK OF PAYMENT:

Any membership may be suspended in the event of default on membership dues within 30 days. A member whose membership has been suspended or terminated will be notified in writing. Members who are delinquent must be paid in full of delinquent funds before entry to facilities. If participant is a grandfathered member, current rates will apply at time of reinstatement, losing grandfather status. Reinstatement requires payment in full at the time of renewal.

CONDUCT:

Inappropriate conduct or an infraction of the rules and regulations set forth by Club Woodbridge may constitute grounds for expulsion. Member(s) who have habitual reprimands or act out with inappropriate behavior will be permanently terminated. If termination occurs, prepaid dues are retained by Club Woodbridge. No refund is given at time of termination and/or suspension. Any unpaid dues at the time of termination are still owed with payment due in full within thirty (30) days of termination.

SECTION 12. RESIGNATIONS

Any member wishing to resign their membership can only do so in writing 30 days prior to the annual renewal date of their agreement.

*If a member moves more than 30 miles from the area, has terminal illness, or financial misfortune, written validation must be submitted to Club Woodbridge a review will be preformed and approval granted by the club director if warranted. Resignations are to be sent 30 days prior to renewal date, if written notice is not received automatic renewal will take place. Please make note of this.

CLUB WOODBRIDGE

REGULATIONS:

In the event of an emergency:

Dial 911 immediately!

A service phone can be identified by a gray box attached to the fence aside the gate of main entrance inside the pool area, the address is written on the door inside the phone box.

OUR FACILITIES & ACCESSIBILITY:

WE ARE A TREE NUT, PEANUT, SEED FREE FACILITY please do not bring nut products on premises.

Products with NUT oils should be used sparingly around other members. Towels must be used when sunbathing on furniture. Secondary contact of nut oils on the water or furniture could/will lead to severe anaphylactic reactions with members suffering from these allergies. THIS IS A MUST! Non compliance could prevent entry, or lead to removal.

Children under 16 years of age MUST be accompanied by an adult/guardian over 18 years of age at all times. Parents/Guardians may not leave children unattended at the pool(s) or in other areas during visits.

Lifeguards are not babysitters. Do not ask them to watch your children if leaving the area, when smoking or running errands.

Smoking is permitted only in designated areas.

Illegal drugs and the use of are prohibited. Anyone found under the influence will be asked to leave property. **Intent to distribute, sell, or found using, or be in possession of will result in immediate termination.**

Hours:

Normal business hours for swimming 12:00 p.m.- 7:00 p.m. 7 days a week weather permitting.

Tennis Courts are by appointment only. Call Club for court time reservations.

The club house is accessible to members during regular business hours.

Clubhouse and pools are available for hourly rentals.

POOL: only non-peak hours during swim season and unrestricted hours for non seasonal rentals.

CLUBHOUSE: will be determined at time of reservation.

Each requires separate rental agreements unless arrangements are made other wise. (Non-members have a different rate than current club members)

Pool Table:

Children under 18 must be accompanied by a parent/guardian when using pool table.

Please do not eat or drink around the pool table.

A signup sheet will be utilized in peak hours for pool table usage.

Do not sit or place items on the pool table.

When finished with play on pool table; return balls, triangle, cover and sticks.

Chairs/tables (poolside/patio):

Chairs and tables are available on a first come-first serve basis.

Members may not reserve chairs.

If you leave the premises please take your belongings with you.

Please do not leave personal property or food on tables or in designated eating areas.

Tables are not to be saved.

Please remove all food and garbage and police area for spills. Alert staff if assistance is needed.

Parking:

Please park along New Camp Creek Church road at an angle to maximize space for others.

Do not block the walkway/sidewalks. Additional parking is available behind tennis courts.

No motorized vehicles are permitted on sidewalks. (golf carts, gas driven scooters or motorcycles)

No skateboarding is allowed in pool area, tennis courts or on sidewalks.

No double parking along road.

Membership Cards:

Cards are required for access to pool, tennis courts and sport equipment usage.

*Single Membership issued single card, Family Memberships issued up to 4 cards

Lost or stolen cards can be replaced for a fee of \$15.00 each.

Guests:

Guest will be held at same standards as members.

Guest Fees are \$7.00 per day, per guest.

Guests must be with a current member at the time of entry. (Members have preference over guests during peak hours, guests may be refused entry when we are at capacity)

MAINTENANCE:

In accordance with state and local health guidelines, at times it may be necessary to close the pools or tennis courts for maintenance and repairs. We will communicate via our website, please check there prior to your visit.

You may also call the club, we will be happy to assist you.

No pets allowed on premises unless medical service animals. Please bring clean up measures for animals.

Be considerate when presenting with animals being sensitive to individuals with animal allergies.

BEHAVIOR & CONDUCT:

We are a family-friendly business! Profanity and discriminatory comments, gestures will not be tolerated, resulting in immediate removal. Keep it clean and fun while respecting all members and guests.

Please be mindful of your behavior, loud shouting and temper out breaks or physical threats will result in removal.

Keep noise (shouting, screaming, rough play) around the pool to a minimum, as it can become difficult for life guards to hear cries for help, and can be disturbing to other guests and members.

Behavior & Conduct con't....

Please bring ear buds or personal headphones while listening to music. If unavailable keep music at a level not found disruptive to others. Profanity or vulgar music is highly discouraged.

Lewd behavior will not be tolerated under any circumstances (i.e. foul language, nudity, intoxication) it will result in immediate removal and could result in termination of membership.

PERSONAL HYGIENE & ATTIRE:

Appropriate attire and foot wear are required when entering club hose.

Wet swimsuits, wet clothing and bare feet, or spiked athletic shoes are NEVER permitted inside club hose at any time.

Sneakers or tennis shoes are the only allowed foot wear on tennis courts. (No Golf shoes, cowboy boots, flip flops or sandals)

Over revealing clothing or swimwear will be discouraged and not permitted. Please utilize dressing areas located in the pool area for personal grooming, changing between sports, putting on swim wear or changing back into regular clothing.

Changing in the restrooms located in the club house is prohibited.

Swimmers may not wear cut off jeans, t-shirts or basket ball shorts while swimming. Only appropriate swim shirts and suits, swim trunks will be allowed.

Clothing found to be, sexually explicit, vulgar, and slanderous or racially insulting will not be permitted on premises.

POOL DECK/PATIO SAFETY:

No Smoking in pool area. Smoking permitted in designated areas only.

No dip, snuff allowed in pool area.

No Gum allowed in or around the pool.

No Running, horse-playing, or rough-housing, pushing or shoving.

During COVID restrictions, members pool side seating may be limited to 4hrs in order to meet the needs of all members during peak times, should the need arise we will go to wait list.

Leave stairs, ladders and walkways clear and free of personal items, floats, toys, rafts. Five (5) feet of clear space is a state requirement around pool.

No personal floats, balls, toys and pool noodles are to be left in pools. Please remove these items at time of exiting pools. They impede water flow and basket function.

Glass containers are prohibited; beverages must be in non breakable containers.

No food or beverages in or immediately around the pools.

Please eat in designated areas only.

No climbing on or over the fences.

Please bring to staff/lifeguards attention any issues of concern.

Valuables should be secured. Club Woodbridge will not be responsible for lost, forgotten or stolen items.

CLUB WOODBRIDGE Pool Rules:

IN THE EVENT OF AN EMERGENCY:

Alert guard and Dial 911 immediately!

A service phone can be identified by a gray box attached to the fence aside the gate of main entrance inside the pool area, the address is written on the door inside the phone box. Everyone must exit the pool.

Emergency Flotation devices are located through out the pool area.

Basic First aid items and EPI pen and rescue inhaler (acute asthma attack) are available, see life guard or staff member.

SWIMMERS:

All Swimmers swim at their own risk.

Adults are encouraged to swim with other adults in the event an emergency could occur.

No Smoking or dip is allowed in the pool area, tennis courts or club house. Cigarette butts should be properly disposed of (receptacle outside of the pool area, near the back entrance to the clubhouse)

Please do not throw or flick cigarette butts or cigars in the grass areas or other areas of our facilities. This will keep little hands and feet safe and premises clean and sanitary.

No diving in water 3 to 5 feet deep.

Jumping on flotation devices from side of pool or diving boards is prohibited.

No hanging, pulling or sitting on the rope with buoys.

Please do not tamper or play with hose while water is being added to the pools.

Children are prohibited from throwing rocks from drain beds into the pool. This may result in damage to; pipes, laterals, skimmers and pump baskets or obstruct water flow.

Please do not stick hands in or around skimmer troughs or baskets.

Remove all dive toys, floats, noodles etc. from pool when exiting pools.

Do not jump, sit, hang on or dive from ladders.

Sponge Balls or athletic balls can not be thrown over or around other members in pool areas, unless, consent is given by life guard.

Please keep steps and ladders clear for safe passage entering and exiting pools

Please do not allow children to sit or play on or around steps of pool, or hang on hand rail.

Please take note- All "swimmers" under 16 years of age, **must complete a swim test demonstrating swim competency.**

Swimmers who do not complete a swim test or fail will not be allowed in water over 3 feet. Swim tests can be repeated if individuals are unable to pass or perform at levels required to pass the test. Parent or guardian(s) must be able to swim for "non-qualified" swimmers to be in water over 3 feet. If neither the child nor adult can swim we ask you stay in 3 foot waters.

Swim floats are not life preservers, if your child is utilizing swim suit floats, or arm floats in the pool parent or guardian(s) are REQUIRED to be in the water and at the side of children at all times.

Do not sit poolside while allowing non qualified swimmers to go off diving boards; parent/guardian MUST be in the water below boards. NO EXCEPTIONS. This is a serious offense and could result in loss of swimming privileges.

DIVE WELL/DEEP END: (5ft-9ft area)

One diver allowed on diving board at a time.

Do not hang from the diving board(s) or rope.

Floats are not permitted in diving area.

Ensure the dive well is clear of other swimmers before diving.

Dive down. Not out. Use both ladders as your guide laterally as a stopping point for diving.

Swimmers **MUST** swim to same side ladder. Do not swim in front of opposite diving board to exit pool.

No loitering is allowed in the dive well when divers are present.

No rafts or floating rings are allowed when jumping from diving board(s).

Children are discouraged from jumping from diving boards with arm floats and goggles this could result in injuries, for which Club Woodbridge will not be held liable.

Be considerate to pool side members and over splash.

No playing on bottom of dive well when divers are present.

The use of dive sticks in dive well area will only be permitted **ONLY** During non peak hours.

No balls are to be thrown to or from the divers on diving boards when other members are present in water or pool side.

TODDLER POOL: (1.5 feet deep)

All rules for large pool are applicable in toddler pool area as well. (you know what we mean)

Gate at toddler pool entrance is to remain closed at all times. **DO NOT PROP OPEN.**

Toddler pool is intended for children five years and under. Childless Adults please do not lounge in toddler pool.

A parent or guardian must be with the child/children in the toddler pool at all times. **No exceptions.**

No diving or jumping is permitted in Toddler pool.

Remove all toys, etc. from pool and/or deck when finished.

Contain small toys around pool. Do not go off and leave toys on pool deck, or floating in pool. It prevents safe passage for other toddlers and obstruct water flow to skimmer basket.

Please do not allow children to play in or around skimmer baskets.

Please do not allow children to throw rocks from drain beds into the pool these could damage pipes, laterals or skimmer and pump baskets obstructing water flow.

Food and beverages are not permitted in toddler pool.

FOOD & BEVERAGES:

Feel free to bring food and beverages for your enjoyment.

No drinks within five feet of either pool.

Food is prohibited inside pool area. Consume food in designated eating areas only.

Prepackaged foods & beverages, fruit snacks and treats are available for purchase.

If you have a spill, please notify staff immediately.

INCLEMENT WEATHER:

Lightning and thunder are cause for dismissal/removal of all swimmers from the pool area. Members and guests will be directed to immediately exit. Restrooms in pool area will be closed, please gather belongings and exit as quickly as possible. Do not retreat to restrooms. Pool will be locked and closed until further notice. With staff/lifeguard permission, swimmers are permitted to re-enter the pool after a minimum of thirty minutes has passed with the absence of lighting or thunder.

Wet swimmers will not be allowed in club house. We ask members to vacate premises and return home or remain in vehicles until threat ends.

In the event of strong wind gusts or high winds. please, lower umbrellas returning them to the downward position.

SANITATION & PRESERVATION

We would like for all of our members to enjoy the benefits of a clean, sanitary pool. We comply with the Center for Disease Control rules and regulations to ensure things continue to run at full capacity and preserve the health and life of our members as well as our swimming pools.

Diapers or swim pants are prohibited in accordance with local and state health policies.

SANITATION & PRESERVATION con't...

Please do not change diapers in or around the pool (including on the lounge chairs and picnic tables). Please enjoy use of the changing tables located in shower house.

In the event of vomiting or fecal matter is present in either pool. NOTIFY STAFF IMMEDIATELY. Pool will be closed immediately, sanitized and reopened 24 hours from incident. No one will be allowed in or around water.

Swimmers who think they might be sick or are sick should not visit the pool in accordance with local and state health policies. This includes pink eye, nasal/ear infection, diarrhea, etc...

Shower before entering pool to remove any germs and/or debris

Swimming members and guests (men, women or others not mentioned) with shoulder length hair are required to pull hair up or utilize a swimmers cap. There are complimentary hair ties available. Long hair is a pumps worse nightmare. Help us keep the pool up and running, without prolonged delays and repair time.

Applying sun products in enclosed areas is forbidden and considered a slip hazard and breathing risk, only apply outside. (not inside clubhouse, or shower house)

As a safety measure apply all Sun products, lotions away from other guests and furniture. If sun block gets on tables and chairs please remove promptly.

Do not apply lotions or sprays while in the pool. Please apply your tanning lotion and/or sun block around ten minutes prior to entering the pool.
